RESOLUTION DECLARING THE VILLAGE OF HOMER WILL PARTNER WITH THE CENTRAL NEW YORK REGIONAL PLANNING & DEVELOPMENT BOARD TO IMPLEMENT A COMMUNITY FORESTRY GRANT

***WHEREAS,** the Village of Homer has created a Tree Committee that consists of a minimum of 5 members; and*

***WHEREAS,** it is the duty of the Village of Homer Tree Committee to develop a written comprehensive plan for planting, maintenance, pruning and removal of trees in the public right-of-way and on other Village-owned land and for requesting approval of funding by the Village Board for such activities; and*

***WHEREAS,** the Village of Homer is a registered Climate Smart Community (CSC) through the New York State Department of Environmental Conservation and is working towards CSC Certification; and*

***WHEREAS,** the Village of Homer and CSC program acknowledge that there are many environmental and economic benefits to maintaining healthy tree canopies, including lower energy use, reduced extreme heat impacts, more carbon dioxide removed from the atmosphere, better air quality, less stormwater runoff, and a stronger sense of place; and*

***WHEREAS,** the Central New York Regional Planning and Development Board (CNY RPDB) was awarded funding through the USDA, Forest Service's IRA Urban & Community Forestry program through grant award 24-DG-11094200-135 (Community Forestry Grant); and*

***WHEREAS**, the objective of the CNY RPDB's Community Forestry Grant is to provide the Central New York region's disadvantaged community (DAC) areas with funding and technical resources to effectively plan for, implement, and maintain urban forestry projects and workforce development programs; and*

***NOW, THEREFORE, BE IT RESOLVED** that the Village of Homer will partner with the CNY RPDB on their Community Forestry initiative by working with CNY RPDB staff, the CNY RPDB's selected forestry contractor, and other project partners to advance community forestry planning, planting, and management in the Village of Homer.*

***BE IT FURTHER RESOLVED** that this Resolution shall take effect immediately.*
